Subject: Hiring and allotment of hotel accommodation in favour of the Police Personnel at Srinagar/Jammu.

**Govt. Order No: 15 - Est of 2016**

**Dated: 04 - 03 - 2016**

Whereas, Estates Department hire rooms in TRC and private hotels on every Darbar Move for move and non-move employees including the Police personnel of various ranks;

Whereas, during the last few years, certain problems erupted in respect of allotments in favour of the Police Personnel;

Whereas, in order to sort out the issues and to have a rational mechanism, a meeting was held on 1<sup>st</sup> February, 2016 under the Chairmanship of Financial Commission, Estates Department in which senior officers of Police Department including ADG Police Headquarter and ADG (Security) participated;

Whereas, after the discussions on various issues, there was a consensus to review the existing mechanism and to put in place effective system of hiring and allotment for optimal use of rented accommodation and cost saving;

Now, therefore, in view of the above, it is hereby ordered with immediate effect that:-

- i) Henceforth hiring of hotels and allotment of hotel rooms at Srinagar/Jammu in respect of Police Personnel including SSG, PSOs, Escort and Permanent Guards/Security upto the rank of Superintendent of Police shall be done by the PHQ. The required funds on this account shall be directly placed at the disposal of Home Department/PHQ. However, the overall number of hotel rooms shall remain same as existed at the time of previous Darbar Move (Srinagar-Jammu-2015-16) i.e;

- ii) Allotment in favour of Senior Police Officers from the rank of Senior Superintendent of Police and above shall be continued to be done through the Estate Department as per the past practice;

Further, the Estates/Police Department shall take all the required steps and measures aimed at:

- i. maintaining of fool proof system of actual occupancy.
- ii. payment of catering charges as per the actual occupancy and presence.
- iii. ensuring proper quality of service being provided in the hotels.
- iv. provisions of necessary security and welfare of the occupants/tenants.
