The Committee shall formulate the list of selected Hotels/ Guest Houses in order of merit based on suitability of the hotels / rooms with reference to following basic facilities for boarding / lodging :-

- a. The quality / standard of the buildings.

- b. Furniture and furnishings in place.
- c. Rooms size and ventilation.
- d. Drinking water and hot water facilities.
- e. Provision of winter bedding.
- f. Power backup facility.
- g. Size of attached lawn / garden.
- h. Quality and arrangements in place of service.
- i. STP facility available in the hotels guest house.

Besides above, the Committee is also authorized to finalize and fix broad parameters and decide the eligibility of hotels / guest houses for hiring by the Estates Department after checking physical infrastructure available with them and submit its report to the Financial Commissioner, Estates Department.


