D a t e d 27.10.2016

Sanction is hereby accorded to the hiring of private houses at Jammu and their allotment in favour of the officers as per the details given in annexure (A) to this order on payment of rent/licence fee as admissible under rules with effect from 01.11.2016 to 30.04.2017. The allottees shall execute necessary licence Deed with the Deputy Director Estates Jammu in this regard and shall also complete all the formalities as required under rules. However, the hiring of these private houses is subject to the payment of rent as shall be assessed by the State Level Rent Assessment Committee.

Further, the allottees shall take possession of their allotted accommodation upto 15<sup>th</sup> November 2016, whereafter the allotment shall be deemed to have been cancelled.
