As recommended by Service Selection Board sanction is hereby accorded to the temporary appointment of Shri Irshad Ahmad S/o Abdul Majid Parray as "Electrician" (Estates Department Divisional Cadre Kashmir) R/o Hygam Sopore Baramulla in the pay scale of Rs. 5200-20200+ GP 2400 with the following terms and conditions :-

- i. *The appointee shall report to the Office of the Executive Engineer, Estates Division, Srinagar within a period of 21 days from the date of issuance of appointment order. In case of failure of appointee to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice.*
- ii. *The appointee shall be allowed to join only on production of the following certificates in original:-*
 - a. *Academic/Technical Qualification Certificates.*
 - b. *Matriculation/ Date of Birth Certificate.*
 - c. *Health Certificate from the concerned Chief Medical Officer.*
 - d. *Permanent Resident Certificate issued by the Competent Authority.*
 - e. *Certificates from the District Industries Centre (DIC) and District Employment & Councelling centre to the effect that no loan under self employment scheme has been taken by the appointee.*
- iii. *The appointment of the above candidate as "Electrician" in the Estates Department shall further be subject to the condition that:-*
 - a. *The appointee shall submit an Affidavit at the time of joining undertaking therein that in case any adverse report about his Character and Antecedents is received from the Office of the IGP, CID, J&K to whom a reference shall be made by the Executive Engineer Estates Division Srinagar, the candidate shall have no right to claim his appointment as "Electrician" in the Estates*

- Department and his appointment as such, shall be deemed to have been cancelled ab-initio;*
- b. Verification/ genuineness of the qualification certificate/ Diploma from ITI in the trade of Electricity or having 10 years experience in the trade from the concerned issuing authorities is received.*
- iv. The salary of the appointee shall not be drawn and disbursed to the appointee unless the satisfactory reports in respect of point (iii) (a) and (b) above are received in his favour.*
- v. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated: 24.12.2009.*
- vi. The appointee shall be on probation for a period of 02 years.*
- vii. The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending in any Court of the competent jurisdiction.*
