Subject:- Compassionate appointment of Mst. Afreen W/o Late Farooq Ahmad Mahajan (Ex-Supervisor) R/o Dalgate Srinagar as Orderly (Class-IV), under SRO-43 of 1994.

Sanction is hereby accorded to the temporary appointment of Mst. Afreen W/o Late Farooq Ahmad Mahajan (Ex-Supervisor) R/o Dalgate Srinagar, in relaxation of the prescribed qualification, as Orderly (Class-IV), in the pay scale of Rs. 4440-7440 with Grade pay of Rs. 1300/- in the office of Executive Engineer Estates Division, Srinagar.

The appointee shall report to the Executive Engineer Estates Division, Srinagar within a period of 21 days from the date of issuance of this order, failing which the appointment shall be cancelled ab-initio. The appointee shall be allowed to join only after production of the following certificates in original:-

- i. Age and Health certificate.
- ii. Academic qualification certificate.
- iii. Permanent Resident certificate.
- iv. Certificate from the General Manager, DIC and Dy. Director Employment concerned to the effect that no loan under self-Employment Scheme has been taken by the appointee.

The appointment shall further be subject to the following conditions:-

- i. Appointee shall give an undertaking in the shape of an affidavit to the effect that in case, adverse report about her character and antecedents is received from the Inspector General of Police, (CID), J&K to whom a reference shall be made by the Executive Engineer Estates Division, Srinagar, the appointee shall have no right to claim her appointment and her appointment, as such, shall be deemed to have been cancelled ab-initio.
- ii. Verification/genuineness of the certificates/documents from the issuing authorities. If, on verification, the Certificates /Documents produced are proved to be fake or forged, the appointment shall be cancelled ab-initio.

- iii. The appointee shall be on probation for a period of two years.
- iv. The appointee shall be governed by the New Pension Scheme as notified vide SRO 400 of 2009 dated 24.12.2009.

The salary of the appointee shall not be drawn and disbursed to her unless the satisfactory reports in respect of (i) and (ii) above are received in her favour.
