Subject:- Hiring/Allotment of Private Houses accommodation at Jammu.



Government Order No. 102 - Est of 2020.

Sanction is hereby accorded to the hiring of Private Houses/sets at Jammu and their allotment in favour of move officers indicated in Annexure-A on repeat basis and move officers indicated in Annexure -B on fresh basis to this order with effect from 01.11.2020 upto ending April, 2021 on payment of rent/license fee as prescribed under rules., subject to the following:

- I. The rent shall be paid as per the entitlement or as per the assessment, whichever is less.
- II. The respective allottee (s) shall take over the possession of the allotted accommodation from Deputy Director Estates, Jammu, within 15 days from the date of opening of offices at Jammu.
- III. The allottee (s) shall furnish an undertaking before Deputy Director Estates, Jammu that neither they nor their spouse own a residential house in Jammu city.




