1. The tender documents consisting of qualifying information, eligibility, criteria, Set of terms and conditions of contract and other details can be seen/downloaded from the departmental website **www.jktenderes.gov.in** as per schedule of dates given in NIT.

2. Tenders must be accompanied with cost of tender document of Rs. 2000/- in shape of demand draft in favour of **Dy. Director Estates Kashmir** or to be remitted in Treasury under major Head 0216- Housing and earnest money in shape of CDR/FDR pledged to **Dy. Director Estates, Kashmir** without which the tenders will not be entertained.

3. The date and time of opening of tenders shall be as per NIT notified on web site **www.jk tenders.gov.in** and conveyed to the tenderers automatically through an e-mail message on their e-mail address. The tenderers of responsive bidders shall be opened on line on same web site in the office of Deputy Director Estates Kashmir. (tender receiving authority)

4. **The earnest money shall be forfeited, if:**

Any tenderer withdraw his tender during the period of bid validity or make any modifications in the terms and conditions of the tenders.

Failure of successful tenderer to execute the agreement within 30 days after fixation of contract.

5. Instructions for tenderers regarding e-tendering process.

5.1 Tenderers are advised to download bid submission manual from the "Downloads" option as well as from "Tenders Manual Kit" on website **www.jktenders.gov.in** to acquaint bid submission process.

5.2 To participate in tender process, tenderers have to get "Digital Signature certificate (DSC)" as per Information Technology Act-2000. Bidders can get digital certificate from any approved vendor.

5.3 The Tenderers have to submit their bids online in electronic format with digital signature. No tender will be accepted in physical form.

6. Tenders will be opened online as per time schedule mentioned in the NIT.

6.1 Tenderers must ensure to upload scanned copy of all necessary documents with the tender.

6.2 **"Tenderers must ensure to upload scanned copies of all necessary documents including earnest money and tender document fee. No document (s) which has/**

have not been uploaded shall be entertained in the form of hard copy. However, in case of any clarification, the bidders shall have to produce original documents in support of soft copies if need arises."

6.3 The earnest money in favour of unsuccessful/ Non-responsive tenders shall be released at the earliest after expiry of the final bid validity latest on or before 30th day after the award of contract.

6.4 The department will not be responsible for delay in online submission due to any reasons.


7. Scanned copy of cost of tender document in the shape of Demand Draft in favour of Deputy Director Estates, Kashmir under Major Head 0216-Housing and earnest money/tender security in shape of CDR pledged to Dy. Director Estates, Kashmir must be uploaded with the documents of the tender.

8. Price escalation and Taxes : The unit rates and prices shall be quoted by the tender entirely in Indian Rupees and the rates quoted shall be deemed to include **price escalation and all taxes** (such as CGST,SGCT etc) and the approved rates shall remain unchanged throughout the period of contract irrespective of any fluctuation in market rates.

9. Tenderers are advised to use "My Documents" area in their user on J&K e- tendering portal to store such documents as are required.

10. Instructions to bidders (ITB)

10.1 All tenderers shall upload the documents as per the following check list:

**TERMS AND CONDITIONS OF TENDER NOTICE ISSUED BY THE

1. e- Tender must be in double cover system according to the directions given in the tender notice.
2. The rate unit must not under any circumstances be altered and the same must be entered in words as well as in figures.
3. Tenders must be submitted by the registered firms/approved suppliers/SSI unit holders only indicating C.S.T. and G.S.T. Nos, Copies of which should be enclosed with the tender along with a certificate from State Taxes Department to the effect that the tenderer has filed the GST return upto ending December,2021 (for those who file GST return quarterly) and January- 2022 (for those who file GST return on monthly basis).
4. The Tenderer must submit income tax return for the assessment year 2021-22
5. Tenderers should be registered with State Taxes Department for Sale/Trading in the commodities quoted for. Copy of the GST and CST Registration be attached with the tender.
6. The tenderer shall be deemed to have carefully examined the conditions, specifications, size, make etc of the material goods to be supplied and the job/services to be provide. If he shall have any doubt as to the meaning of any portion of these conditions or of the specifications, size , make patent etc, he shall before filling the tender, refer to the Deputy Director Estates, Kashmir and seek clarification within the stipulated time frame.
7. The contractor/agency shall not assign or sublet his contract or any part thereof to any other agency. If this is done the contract would be liable to termination and CDR forfeited. Besides other legal action as warranted under rules.
8. All the items supplied shall be of the best quality, to the specification, trademark laid down for them and strictly in accordance with the approved standard samples. The decisions of the Regional Level Purchase/Contract Committee Kashmir shall be final as to the quality of the goods/material and shall be binding upon the tenderers. The articles not conforming to the standards or specifications laid down for them, shall be rejected or replaced entirely on the expenses of the tenderer and within reasonable time to the best satisfactions of the Committee.
9. The Deputy Director Estates, Kashmir or his duly authorized representative shall have at all reasonable time access to the supplier's premises and have the power at all reasonable time to inspect and examine the materials and workmanship of the goods.

10. The tenderer shall be responsible for the proper packing so as to avoid any damage during the transportation and delivery of the material in good conditions. No extra cost on such account shall be admissible.
 11. The tenderer whose tender is accepted shall arrange supplies within the stipulated period as shall be reflected in the supply order according to the requirement of the department. In case it fails to supply the same within the specified time frame, the department reserves the right to blacklist the firm and forfeit its CDR.
 12. The contract of supply can be repudiated at any time if the supplies are not made to the satisfaction of Deputy Director Estates, Kashmir.
 13. **Bidder who does not wish to quote rate of any item should write 0.00 or left the rate column blank.**
 14. The tenderer should sign the tender form and document at each page at the end in token of the acceptance of all the terms and conditions of the tender and the agreement.
 15. The tenderer should submit the tender form in two parts i.e. Technical bid and financial bid. If a tenderer qualifies the technical bid only then his financial bid will be opened.
 16. The tender must be accompanied by an earnest money as stipulated in the tender Notice without which tender will be rejected. **The hard copies of bids shall be obtained only from the bidder who is declared as L1 after opening of Financial bids. Similarly the original CDR (hardcopy) duly pledged to Deputy Director Estates, Kashmir shall be obtained from successful tenderer before allotting the work or issuing the supply order. The original CDR will be retained and treated as security till the execution of the contract in full. No interest will be paid by the department on this amount. The CDR's of unsuccessful bidders shall be released after finalizing the rate contract.**
 17. The successful tenderer will have to enter into an agreement with the Deputy Director Estates, Kashmir within 15 days from the communication of the acceptance of the tender. One copy of the agreement will be retained by the supplier/firm and two copies will be furnished to the Deputy Director Estates, Kashmir out of which one copy will remain in the personal custody of the Deputy Director Estates, Kashmir and the other in the office till the refund of earnest money and execution of the contract in full.
 18. Advance payment will not be made under any circumstances. Payment shall be due and payable by the Deputy Director Estates, Kashmir on behalf of the Lt. Governor, J&K only when a claim in the format bill in triplicate is preferred after the whole quantity has been delivered, inspected and accepted by the Deputy Director Estates, Kashmir or his duly authorized representative and a certificate of having done so is recorded in the bill by the I/c, Stores, Deputy Director Estates, Kashmir. In case of disputed items the payment shall be withheld till the settlement of the dispute.

19. The validity period and the delivery period can be extended if mutually agreed to.

20. If the approved supplier fails to supply goods/materials of prescribed specifications or fail to supply within the specific period, the Deputy Director Estates, Kashmir shall be at liberty to arrange supply either through retender or otherwise. The loss so sustained by the Department or extra cost incurred by the Government shall be made good from the supplier.

21. The Deputy Director Estates, Kashmir reserves the right to accept or reject any tender without assigning any reasons thereof.

22. All legal proceedings, if necessity arises, to be initiated by any of the parties (Government or Contractor) shall lie in a court of competent jurisdiction in the Union Territory of J&K only and nowhere else.

23. Conditional tenders shall not be accepted.

24. Bills on account of payment of cost of material/goods supplied may be submitted to Deputy Director Estates, Kashmir indicating GST as a distinct component wherever applicable.

25. Payment on account of supplies made shall be subject to availability of funds during the current financial year and satisfactory report of the Committee regarding physical & technical verification.

26. If at any time successful tenderer fails to supply the material within prescribed period, Deputy Director Estates, Kashmir shall be free to procure the material from the second lowest tenderer and the cost of differential shall be recovered from the approved tenderer/Supplier.

27. The prospective supplier may obtain approved sample of the items of supply wherever applicable from Deputy Director Estates, Kashmir before submission of their tender documents and in no case material other than the specific quality mentioned in the proforma of items compiled by the store.

28. Submission of wrong information/document by bidder regarding relevant documents will lead to penalties as per law and may include permanent debarment from applying in department tenders in future, besides cancellation of instant contract.

29. The supply should reach the office of Deputy Director Estates, Kashmir or designated stores/sites as shall be mentioned in the supply order full in one time (not in breaks) as per supply order.

30. The CDR's of unsuccessful bidders shall be released after finalizing the rate contract.

31. Fall clause shall apply as a measure of price safety mechanism if the rate contract holder reduces its price or sell or even offer to sell the rate contracted goods or services following conditions of sale similar to those of the rate contract at a price lower than the rate contract price, to any person or organization during

the currency of rate contract, the rate contract price will be automatically reduced w.e.f the date for all the subsequent supplies under the rate contract and rate contract shall be amended accordingly.

32. The basic principles to be followed in case of repair work(furniture/electric and electronic items etc) shall be as:-

- i) The rate contract for repair work shall not be splitted between two or more bidders so as to avoid possible inconvenience to the department.
- ii) The bidder who will qualify for maximum items shall be awarded the rate contract on the condition that he has to accept the lowest rate of other items offered by any other bidder.
- iii) The tactics of Pool/Cartel formation which is against the basic principles of competitive bidding is an offence under the Competition (Amendment) Act 2007. In case of any evidence of Pool/cartel formation suitable action as warranted under rules shall be resorted to, and shall lead to rejection of bid.

33. Any other terms and conditions of General Financial Rules 2017 shall be applicable at any time.

34. The terms and conditions of Rate Contract/agreement shall be part of the tender and are to be followed in letter and Spirit.
